Annually, there are approximately **1,500 children in foster care** in Tulare County, but CASA is only able to serve **275 of them** with volunteers and **200 of them** with CASA staff. Our goal is to raise the necessary funds to recruit, screen, train, and support enough volunteers to ensure that every child in foster care has the advocate they deserve. We hope you will partner with us to help achieve this goal.

The proceeds from the **Once Upon A Dream Gala** account for a third of CASA's annual operating budget, allowing us to continue our essential work. Your support will help us train volunteers, enhance our programs, and provide the resources needed to advocate for each child's best interests—ensuring they have the chance to build a brighter future despite their circumstances.

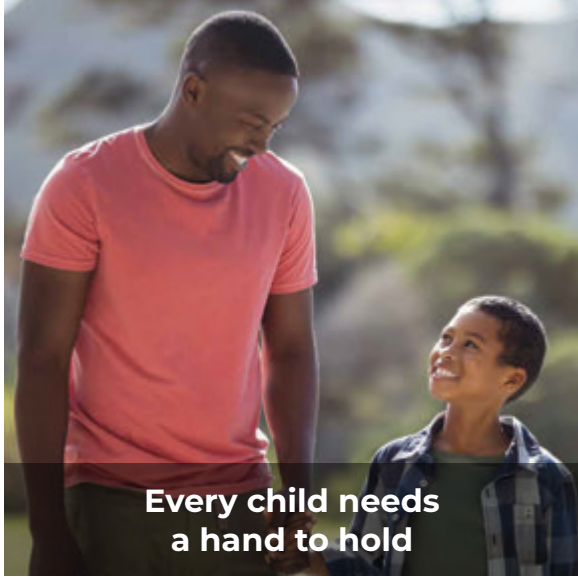

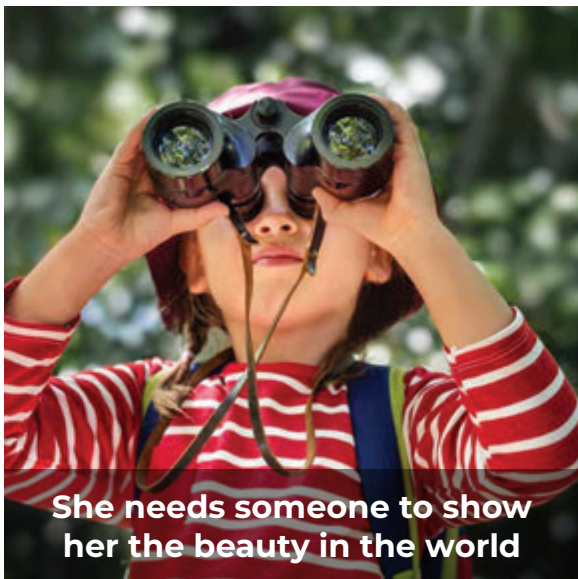
